### RD195 Cosmetics and Bodycare Certification Scheme Charges

Valid from 04/01/2010. Charges are under review and may be revised at any time. The fees relate to inspection and certification charges but do not guarantee that a Certificate of Compliance will be issued.

All applicants to the OF&G Cosmetics and Bodycare Certification Scheme are required to submit an Initial Assessment Fee with their application, which is redeemable against your Annual Fee in the first year. This assessment is to ensure that your products comply with the organic requirements.

Following successful completion of the Initial Assessment we will carry out an Inspection, for which there will be a further charge, depending on the turnover of your organic cosmetic and bodycare enterprise. Please see details below.
